# 1. WHAT PERSONAL DATA WE COLLECT

When you access to our Website we may collect the following Data automatically:

- Internet Protocol (IP) address, OS;
- Browser, device information (device ID, hardware model, etc.);
- Country, location, language, GPS;
- Time of access to Website, clickstream data, time stamps, page response time, occurring errors, duration of visits to pages;
- Services you searched/viewed, information about the relationship of pages (scrolling, clicks and mouse hovering), page interaction information;
- Google Analytics;
- Cookies;
- Other technical info that does not reveal your identity.

#### 2. HOW WE USE YOUR PERSONAL DATA

Your Data may be used by Us for various purposes including, but not limited to:

- To provide you timely and full access to our Services;
- To fulfil our contract obligations;
- To prevent unlawful activity and to protect your interests. Although, THEDOGS LTD is not liable to provide any security services we do our best to detect and prevent damage to our Users;
- To comply with applicable laws and regulatory requirements related to protection of Personal Data;
- To provide you technical support. We may use your Data to send you administrative information about changes to our terms, conditions and policies;
- To be able to receive feedback from you and update you with latest information about our Platform/Services;
- To carry out verification activities;
- For business purposes and marketing.

## 3. HOW WE PROTECT YOUR PERSONAL DATA

We will do our best to protect your Data from unauthorised access with our system of organisational and technical security measures. These security measures fully comply with applicable laws and meet the highest standards in the Data protection sphere. However, despite the above facts it is impossible to achieve complete security of your Data.

You hereby acknowledge and agree that THEDOGS LTD will not:

- a) be liable for any loss or damage which may occur due to unauthorised access to your Data;
- b) hold any responsibility for any actions committed by any service providers or any other third parties;
- c) be liable for any leak of Data and any loss or damage it may cause.

## 4. HOW LONG WE KEEP YOUR PERSONAL DATA

We will only keep your Personal Data in an identifiable format for the least amount of time necessary to fulfil our legal/regulatory obligations and for our business purposes. We may retain your Data for longer periods than required by law if it is in our legitimate business interests and is not directly prohibited by the applicable law. When Personal Data is no longer necessary for the purpose for which it was collected, we will remove any details that identifies you or we will securely destroy the records, where permissible. However, we may need to maintain records for a significant period of time (even after you cease using our Services) if it will be required by law (tax, accounting, other legal purposes).

#### 5. COOKIES

We may log information using "cookies". When you visit the Website, we invite you to read and accept our use of cookies. By accepting the banner and continuing to use the Website, you agree to the placement of cookies in your browser in accordance with this Policy. A cookie is a small text file that is stored on your computer to help us make your visit to our Website more convenient. Cookies provide us with information about your use of the Website that can help us to improve it. We will process Personal Data collected through cookies in accordance with this Privacy Policy. You may refuse cookies by turning them off in your browser, however, you should be aware that our Website, like most other sites, may not work well with cookies disabled.

# We use the following Cookies:

- Strictly necessary Cookies. These are Cookies that are required for the operation of our Website.
- Analytical Cookies. They allow us to recognize and count the number of visitors and to see how visitors move around our Website when they are using it. This helps us to improve the way our Website works.
- Targeting Cookies. These Cookies record your visit to our Website, the pages you have visited and the links you have followed. We may also share this information with third parties for this purpose.

### 6. THIRD PARTY SERVICES

The Website may include links to third party resources which we have no control of. The fact that such information is displayed on the Website does not mean that THEDOGS LTD approves content provided on such websites or is in any way related to it.

These links provided for your convenience only, once you follow the link and leave the Website you will no longer be governed by this Policy and you should refer to third party website Privacy Policy.

#### 7. PERSONAL DATA TRANSFER

## 8. DISCLOSURE OF YOUR PERSONAL DATA

You hereby acknowledge and agree that THEDOGS LTD have the right to disclose and share your Data with any person/in any circumstances defined below:

- Third Party Service Providers, if it is necessary to supply Services you have requested, or to provide additional technical and customer support; and/or to provide other support to us and to the Services;
- If THEDOGS LTD will be involved in a business transition or any merger projects, Data might be transferred to a new company. Such company will possess the Personal Data collected by us and will assume the rights and obligations regarding your Personal Data as described in this Policy.
- We may share your Personal Information with law enforcement, and government officials when we are compelled to do so: (i) by a subpoena, (ii) a court order to prevent financial loss, (iii) to report suspected illegal activity, (iv) in connection with any legal investigation, (v) to comply with relevant laws or to respond to subpoenas, warrants, or other legal process served on THEDOGS LTD, (vi) to protect or defend the rights or property of THEDOGS LTD or users of the Service, (vii) to investigate or assist in preventing any violation or potential violation of the law, this Privacy Policy, or our Terms of Service.
- If it is necessary to fulfil the purpose for which you provided Data, or with your prior consent.

### 9. PERSONAL DATA ACCESS AND CONTROL

If you are located in the European Economic Area, United Kingdom or Switzerland certain aspects related to your Data will be regulated by European and UK General Data Protection Regulations ("GDPR"). In this case you will also have additional rights such as: (i) right to be informed, (ii) right of access, (iii) right to rectify, (iv) right to erasure, (v) right to data portability, (vi) right to restrict processing, (vii) right to object, (viii) right to withdraw consent.
